VI. READING/APPROVAL OF APRIL 15, & MAY 6, 2025, REGULAR MEETING MINUTES

- Mr. Bill Keller made a motion to approve the April 15, 2025, Public Hearing and Regular Meeting Minutes as presented. The motion was seconded by Mr. Rick Ogden. The motion passed unanimously.

VII. OLD BUSINESS

- Discussion regarding current recruitment efforts including Summary of June-December 2025 advertising campaign proposals from ABC and CBS
 - a) Lieutenant Debbie Sumrall gave a brief overview of the CBS 42 advertising analytics. She stated that she requested the campaign be paused to film one (1) more commercial to push towards the end of the campaign which ends on May 31, 2025.
 - b) Lt. Sumrall also provided a spreadsheet comparing advertising packages she's discussed with NBC/WVTM, ABC 33/40, and CBS 42 and the benefits and differences between each campaign proposal. There was lengthy discussion regarding past and current advertising efforts and the impact to applications received and whether efforts need to take a more dynamic, creative, and inventive approach to the issue of recruitment.
