Mr. Phil Burns, Chief Operating Officer for Shelby County, was in attendance and answered any questions Board members asked about the current economic state of the County. Board members also briefly discussed their own individual research and presented that information during the meeting. Discussion often turned towards the importance of cost of living adjustments for recruitment and retention efforts. Mr. Guercio opened the floor to public comments. Many of the comments centered on recruitment and retention concerns.

VI. PUBLIC COMMENTS

Sgt. Crystal Motley spoke to the difficulties of recruiting, specifically in the Jail Division, and how a cost of living adjustment would be beneficial. She noted that a cost of living adjustment would help with both recruitment and retention.
