# VI. READING/APPROVAL OF AUGUST 19, 2025, REGULAR MEETING MINUTES & AUGUST 28, 2025 WORK SESSION

- 1) August 19, 2025, Regular Meeting Minutes
  - a) Mr. Bill Keller made a motion to approve the August 19, 2025, Regular Meeting Minutes as presented. The motion was seconded by Mr. James Sellers. The motion passed unanimously.
- 2) August 28, 2025, Work Session
  - a) Mr. Bill Keller made a motion to approve the August 28, 2025, Work Session Minutes as presented. The motion was seconded by Mr. James Sellers. The motion passed unanimously.

#### VII. NEW BUSINESS

- 1) Marketing Presentation by Ms. Erin Prady
  - a) Lt. Debbie Sumrall opened the presentation stating that there were still a lot of proposals under review and she and Ms. Prady was working to narrow them down. Ms. Prady discussed the options available for both packages presented from iHeart Media and CBS 42. There was discussion regarding terminology and specific features from each advertising package. Ms. Prady and Lt. Sumrall both recommended the CBS 42 package for the features available, past advertising history, and cost of the package presented. The Board discussed the importance of keeping advertising continuous and took the recommendation under consideration.

# VIII. DISCUSSION REGARDING POTENTIAL COLA ADJUSTMENT & BONUS PROGRAM

Mr. Jake Guercio opened discussion and stated the LEPB would have liked to do more than they feel able to do at the present time. There was discussion regarding current economic conditions as well as requests for the LEPB to review some current policies regarding longevity pay or reviewing the current pay scales. The LEPB took all requests under consideration. The Board noted that if conditions should improve at a later time, then they would revisit making an additional COLA to the current proposed one-time payment of \$1,000.00. Mr. Bill Keller made a motion to approve a one-time COLA payment to Shelby County Sheriff's Office employees hired prior to September 1, 2025. The motion was seconded by Mr. Rick Ogden. The motion passed.

Mr. Guercio discussed interest in developing an Employee Referral System. The referral bonuses would be paid by the LEPB. He stated he would speak to legal counsel to make sure that it was possible. Board members recognized that employees often make the best source of referrals and would like to incentivize employees. It was noted that Shelby 911 had

It was noted that some area agencies were closing in on the current pay scales and current incentives may not be enough to keep more tenured employees longer. Current economic conditions were again discussed. The LEPB stated they would take the requests under consideration.

There being no further business, Mr. Bill made a motion to adjourn the meeting. The motion was seconded by Mr. James Sellers. The motion passed unanimously.
