I. CALL TO ORDER AND WELCOME

IV. ADOPTION OF AGENDA

Mr. Bill Keller made a motion to approve the agenda with an addition to Item X. BILLS/INVOICES. The motion was seconded by Mr. Jake Guercio. The motion passed unanimously.

V. READING/APPROVAL OF JANUARY 4, 2022, MEETING MINUTES

Mr. Bill Keller made a motion to accept the meeting minutes as presented. The motion was seconded by Mr. Jake Guercio. The motion passed unanimously.



VI. COMMITTEE REPORTS

Regarding the request to the Shelby County Legislative Delegation for the funding increase for the LEPB, Mr. Jake Guercio reported that Representative Corley Ellis emailed a copy of the proposed budget request to the Shelby County Reporter newspaper for public announcement.

VII. CORRESPONDENCE AND MESSAGES

Notices from Sheriff's Office about Merit Step Raises and Fitness Incentives were reviewed, no action required.

VIII. OLD BUSINESS

Receipt of letter from attorney Mr. William Gray to the LEPB regarding his client Sgt. David Black, was acknowledged. No action was taken or anticipated.

IX. NEW BUSINESS

- 1. Review of test scores for Deputy Sheriff, Jail Deputy, and Admin positions from January 14, 2022, testing.
 - a. Board Secretary, Mr. Lyle Mitchell, made a motion to accept the test scores as presented. The motion was seconded by Mr. Jake Guercio. The motion passed unanimously. Copies of the approved test scores were provided to Major Fondren.
- Education Incentive Request from Deputy Daniel Cates for 10% salary increase
 for acquiring a bachelor's degree in Criminal Justice with a minor in Psychology
 from the University of Alabama, accredited by the Southern Association of
 Colleges and Schools Commission on Colleges, recognized by the U.S.
 Department of Education. Degree awarded December 2021.
 - a. Board Secretary, Mr. Lyle Mitchell, made a motion to approve Deputy
 Daniel Cates's request. The motion was seconded by Mr. Alan Miller.
 The motion passed unanimously.
- Jail Deputy Crystal Bryant requested an additional 30 days from the Reserve Sick Leave Bank. Jail Deputy Bryant joined the Reserve Sick Leave Bank Program in 2018 and her last two (2) days of contribution were to be submitted in 2021.
 - a. Mr. Bill Keller made a motion to approve Jail Deputy Crystal Bryant's request. The motion was seconded by Mr. Alan Miller. The motion passed unanimously.
- 4. Discussion of CALEA Certification. Major Jay Fondren and Captain Mark Bishop reviewed the CALEA program and the additional employment and application steps needed by the LEPB in order to achieve next tier certification.

- 1. Approval of reimbursement request from Ms. Warren for \$164.77 for refreshments for January 4, 2022, regular meeting and reception.
 - a. Mr. Bill Keller made a motion to approve Ms. Warren's reimbursement request. The motion was seconded by Board Secretary, Mr. Lyle Mitchell. The motion passed unanimously.
- 2. Net-to-Net, Inc. Invoice 9795 for \$830.00
 - a. Mr. Bill Keller made a motion to approve the invoice for payment. The motion was seconded by Mr. Alan Miller. The motion passed unanimously.
- 3. December YTD Budget Report & January MTD 2022 Budget Report were reviewed, no action required.

XII. ELECTION OF OFFICERS

With no further nominations made, Mr. Lyle Mitchell declared Mr. Randall Donaldson the Board Chairman for 2022.

Board Chairman, Mr. Randall Donaldson, opened the floor for nominations for the office of Board Secretary. Mr. Jake Guercio nominated Mr. Lyle Mitchell. Mr. Randall Donaldson called for nominations for Board Secretary two more times. With no further nominations made, Chairman Randall Donaldson declared Mr. Lyle Mitchell Secretary for 2022.

XIII. EXECUTIVE SESSION

Board Secretary, Mr. Lyle Mitchell, made a motion to go into executive session.

The Board discussed the need for a Salary Survey for the Sheriff's Office employees, ideally to be completed by June 1, 2022. The Board asked Ms. Warren to make an inquiry with Industrial/Organizational Solutions, Inc. to determine if IOS conducts salary surveys.


