VIII. NEW BUSINESS

- 1) Request from Sheriff Samaniego to begin new hire Brad Scott at Step 5 of the LEPB Pay Scale Rev-1 October 1, 2022.
 - a) Mr. Lyle Mitchell made a motion to approve the Sheriff's request. The motion was seconded by Mr. Jake Guercio. The motion passed unanimously.
- 2) Request from Sheriff Samaniego to raise employees listed in the request letter one step and to approve the action prior to October 1, 2022.

- a) Mr. Bill Keller made a motion to approve the Sheriff's request. The motion was seconded by Mr. Jake Guercio. The motion passed unanimously. A copy of the request letter will be maintained with the minutes.
- 3) Request from Sheriff Samaniego to change Marie Wathen's classification from Communications Officer to appropriately reflect her current duties as Jail Deputy.
 - a) Mr. Lyle Mitchell made a motion to approve the Sheriff's request. The motion was seconded by Mr. Jake Guercio. The motion passed unanimously.
- 4) Review/Approval of September 9, 2022, Deputy Sheriff, and Jail Deputy test
 - a) Mr. Jake Guercio made a motion to approve the test scores as presented. The motion was seconded by Mr. Bill Keller. The motion passed unanimously. A copy of the test scores were provided to Major Fondren
- 5) Mr. Randall Donaldson asked the Board to review all educational incentive requests presented so that that all requests could be grouped into one motion. Mr. Bill Keller made a motion to approve all educational incentive requests. The motion was seconded by Mr. Lyle Mitchell. The motion passed unanimously.
 - a) Deputy Sheriff Matt Glassford requested a 10% educational incentive for earning a Bachelor of Science degree in Human Resource Management from Faulkner University.
 - b) Deputy Sheriff Pamela Diane Fenn requested a 10% educational incentive for earning a Bachelor of Science in Criminal Justice degree from Faulkner University.
 - c) Deputy Sheriff Colin Johnson requested a 5% educational incentive for earning an Associate in Applied Science in Criminal Justice with the Police Academy option from Eastern Gateway Community College.
 - d) Jail Deputy William Collum requested a 5% educational incentive for earning an Associate in Applied Science in Criminal Justice from Eastern Gateway Community College.
 - e) Sergeant Clayton Smith requested a 15% educational incentive for earning a Master of Justice Administration from Faulkner University.

- 6) Review of August and September 2022 Budget Reports were reviewed with no action taken.

X. OTHER BUSINESS

High Noon is scheduled to provide a presentation on a recruitment campaign to the LEPB tentatively scheduled October 4, 2022, regular board meeting. Mr. Jake Guercio noted that October 4th is the same day as National Night Out and presents a scheduling conflict for himself and others at the Sheriff's Office.

The Board agreed to move the October 4, 2022, regular board meeting to October 11, 2022. The meeting time will remain 4:00 p.m. and the location will be the Shelby

County Services Building on Highway 280. Danielle Warren is to contact High Noon to reschedule their presentation.

Mr. Dale Gorham of Net-to-Net, Inc., discussed the computer and equipment upgrades/additions as well as proposed website upgrades/improvements for the LEPB.

Two more meetings must be held to pass the proposed amendment to educational incentives and Mr. Randall Donaldson asked if it would it be possible to meet Wednesday, September 28, 2022, in Pelham. After review, the Board agreed they could meet at 9:00 a.m. at the Pelham County Services Building to hold a public hearing and a special meeting regarding the matter. The second meeting, if required for further discussion or debate, will be held on September 29, 2022, at 8:00 a.m. in the LEPB Offices located in the Shelby County Courthouse.

Each attorney took turns stating their respective client's positions. The rehearing ended at 5:25 p.m. and the Board reconvened into regular session immediately after.
